A Ray of Hope received many requests for assistance in 2019 from needy individuals and families. There were 413 requests for a hand up - 126 requests for housing with 96 approved. 46 of those requests were for Peggy's House. There were also 310 requests for benevolence and, sadly, 96 were denied assistance due to lack of funding or space or other. AROH provides a shelter for the homeless and a place for people to rehabilitate from drug and alcohol use. The organization also provides funds to families with children for utilities, rent, and other items in order for them to maintain a safe home. The organization provides counseling and referral services to aid people to gain self sufficiency.

The organization operates a thrift store to provide occupational training to clients and to support the mission of the organization by providing needed clothing and household items.
